## **CONFLICT POLICY**

GRADUATION REQUIRES EACH STUDENTS TO ATTEND EVERY MODULE, and or 180 hours personal contact with the lead teacher, Kristen McQuaide.

Should a conflict arise causing you to miss 1-3 yoga teacher training weekends there are two options to make it up.

OPTION 1: You can make up the information through a private lesson at the rate the studio charges, \$45 per hour.

OPTION 2: You can make up the information during a future 200 HR Yoga teacher training on the day the same material is being covered.

If you miss 4 or more weekends you will have to retake the training at a discounted rate, subject to space availability in that training.

## **Absence due to Covid-19.**

In the event a student is infected with Covid-19 and can show proof of being infected we will customize the best solution to make up the missed material based on the students individual needs.

In the event that the teacher is infected with Covid-19 the training will either be taught online, or it will be moved to another date.

## **PAYMENT PLANS**

Less the \$500 deposit, \$4000. Agreed upon monthly payments are due on the first day of each month beginning October 1, 2023, the last payment is due by March 24, 2024

## **PAYMENT INFORMATION**

Per the Payment Plan selected, the Student agrees to pay the balance of the Program Tuition either by pre-paid/post-dated checks payable on the first day of each successive month, or by Credit Card via Mindbody Online.

Payment by credit cards incurs a 3% processing fee. Make checks payable to "**The SPACE**" and mail with Enrollment Agreement to: **The SPACE, 525 E Acequia Ave, Visalia, CA 93292**

All payments for tuition must be paid on time, no later than April 15 for Payment Plans A & B, and no later than the first day of each month for Payment Plan C.

Any payment that is received by THE SPACE after required dates will forfeit any Discount offered. If mailing a check for your Tuition Balance due, please allow the following delivery times - 5 days for domestic mail: 10 days for international mail.

**CANCELLATIONS & REFUNDS**

**1) Cancellation of Student Agreement (before September 1, 2023)** – Students will receive a full refund of the Deposit, less a \$100 Cancellation Fee if THE SPACE receives a written Notice of Cancellation before September 10, 2022.

**2) Withdrawal or Dismissal (after September 11, 2023)** - If you withdraw or are dismissed from the Program between September 11, 2023, and September 17, 2023 you forfeit all of the Deposit and are entitled to a 50% refund of Tuition paid; B) If termination occurs between September 23, 2023, and the completion of the Program, there will be no refunds for any reason.

**3) Refunds** - Payments for refunds are made within 30 days from receipt of written Notice of Cancellation, Notice of Withdrawal, or after the effective Date of Dismissal from the program. If you withdraw or are dismissed from the Program after September 23, 2023 you are obligated to pay full Tuition.

NOTE: If you withdraw or are dismissed from the program after January 1, 2024, and you have not completed your payments, you are obligated to pay full Tuition for the Program.
